Our kittens/cats are sold as indoor cats only. They shall not be declawed. Breeder will have First Right of Refusal should Purchaser ever need to re-home the cat/kitten. Under no circumstances will this cat/kitten be surrendered to an animal shelter. For kittens, the litter has been registered and it is up to Purchaser to register the individual kitten. For older cats, it is up to Purchaser to complete the Transfer of Ownership. Any breach of this agreement will result in surrender of this kitten/cat back to breeder without Court Order.

**Health Guarantee:**

Kittens/cats are guaranteed free of feline leukemia virus (FELV) and feline immunodeficiency virus (FIV) prior to receipt. All kittens are vaccinated with their first three (3) vaccinations at 8-weeks, 11-weeks and 14-weeks of

age and their rabies vaccine. They are guaranteed free of internal and external parasites and are veterinarian-checked prior to going Purchaser. Parent cats have been DNA tested for over 50 genetic disorders, and offspring are guaranteed to be free of genetic defects affecting their health for two (2) years.

If a cat becomes ill within thirty (30) days of receipt, and your veterinarian tests find your kitten has a bacterial, fungal or viral infection that was present prior to pick-up, breeder will, upon return of ill kitten/cat or with proof of death, replace your kitten with a new kitten of your choice from the next available litter. Breeder does not pay any veterinary costs after pick-up. Kitten will go home with the option of free 30-days of Trupanion pet insurance if buyer elects to participate in said program.
